

## Lacey Family known to Clirehugh

Stamford Vair Clirehugh (1868–1943), a distant cousin of mine, is my entry point to the Lacey family. Stamford was the partner of Ernest Matthew Lacey in the electrical engineering firm of Lacey, Clirehugh & Sillar. He was also a family friend of Ernest's and lived with Ernest's wife Emma as a married couple. I have found no marriage record for Stamford and Emma. Emma, who died before Stamford, was, in her probate record, named as Emma Lacey, the wife of Ernest.

This family lived in England.

This document is an inventory of the records I have seen and the correspondences I have had regarding the Lacey family. I began my research in June 2006 after a phone call from Matthew C. Lacey, a grandson of Ernest, after he discovered my Clirehugh family information. My biggest partner in the research has been Lorna Cowan, a descendant of Ernest's brother Thomas William Lacey. ### Divorce Records

#### **The Divorce of Emma Warner Lacey and Ernest Matthew Lacey**

On 8-18-1893 Emma filed for divorce from Ernest claiming he had sex with other women, including prostitutes, and gave her gonorrhoea. Her lawyer was E. H. Adcock. In her petition Emma stated:

- She married Ernest on 8-1-1888 at Christ Church Streatham, Surrey.
- The newly married couple lived on Glenthorne Road, Brentford, Middlesex, later at Somerset House, Brentford, and currently at 28 Linden Gardens, Bayswater, Middlesex.
- The couple had three children: Robert Markwell Sleigh Lacey age 4, Frank Philip Sleigh Lacey age 2. Ernest Frank Sleigh Lacey was born 7-14-1890 and died 8-1890.
- Ernest's adultery began 10-1-1892 and continued until two days before the divorce petition was filed. She named 4 prostitutes and gave their addresses. She gave the address of a 5th prostitute whose name she did not know.
- Emma claimed Ernest contracted venereal disease, later identified as gonorrhoea, from a woman unknown to her in July 1893 and "willfully and recklessly communicated that VD to her "and was thereby guilty of cruelty to her."

Emma asked for a divorce, custody of her children, that Ernest pay the costs of the divorce and anything else "our Lordship may seem meet."

Thus began a protracted series of hearings and affidavits. Emma affirmed she knew no details of Ernest's adultery. She claimed "there is not any collusion or connivance between me and my husband Ernest Matthew Lacey in any way whatever." Ernest gave her VD "she believe it was on the 20th July 1893. . . . She found herself suffering from illness on or about the 8th August 1893."

Ernest's lawyers were Lake Beaumont and Lake. On 12-19-1893 Ernest confirmed there was no collusion or connivance between him and Emma. He denied the adultery charges and that he had acquired VD or communicated it to Emma. His Answer: "3. That the Petitioner condoned the adultery (if any) of the Respondent by cohabitation with him on August 4th, 1893. 4. That the Petitioner connived at the adultery (if any) of the Respondent in that she instigated the Respondent

in the month of June 1893 to invite her Solicitor Edward Harry Adcock to dine with him at his Club, that after such dinner at her instigation the said Edward Harry Adcock invited the Respondent to accompany him to the Empire Music Hall and . . . when there introduced him to a prostitute with a view to his committing adultery with her.”

On 1-31-1894 Emma denied Ernest’s claims. On 3-3-1894 Emma itemized the dates and places she had “marital intercourse” with Ernest in summer 1893. During this time Emma had custody of her two sons and Ernest’s access to them was limited to 1–3 hours every fortnight. Hearings and affidavits continued throughout 1894.

On 4-30-1895 the petition was dismissed, Emma to pay Ernest’s legal costs.

Ernest countered on 4-28-1894 with claims of his own: that Emma had committed adultery with Frank William Howett<sup>1</sup> in Fall 1892 and Spring 1893, that she had committed adultery with Edward Harry Adcock, that she had contracted gonorrhoea from Mr. Adcock. Ernest claimed damages from Edward Adcock in the amount of £5000. In this suit Emma had as solicitor Atkinson and Dresser. Emma denied the claims and reiterated her claims against Ernest. Edward Adcock denied the claims as did Frank Howett. Ernest denied Emma’s claims. This petition was dismissed on 4-30-1895 “each party to pay their own costs.”

The court records were closed until 1996 (100 years).

Regarding the possibility of gonorrhoea, Emma had four children some time later (1894, 1896, 1900, and 1902), Ernest and Emma each lived many more years, Ernest dying in 1945. There was no affidavit by a doctor confirming the disease. All of which evidence suggests there was no gonorrhoea.

All in all this petition appears to be the result of anger, spite, and a desire for retribution. Several things point to Emma’s having money of her own, which suggests she could have separated from Ernest with no legally-mandated financial support. She wanted custody of the children, which she might not have been allowed if she had just set up her own household.

This opinion changed when I learned of the following story.

### **The Divorce of Sarah and Edward Harry Adcock**

On June 30, 1890 Edward Harry Adcock married Sarah Bridges in the British Embassy in Paris. On February 8, 1894 Sarah filed a divorce petition, as “the lawful wife of Edward Harry Adcock, solicitor, of Danehurst Epsom and 30 Finsbury Circus, London.” She stated that between late April and late June 1893, Edward Adcock and Emma Warner Lacey committed adultery at Danehurst Epsom<sup>2</sup> (Edward’s house), and that they cohabited there from June 30, 1893 through August 24, 1894. Edward and Emma also committed adultery at Emma’s house “Campville” during this same April–June 1893 time frame. It also states Edward had committed adultery “on or about July 18, 1893 with some woman unknown and thereby contracted gonorrhoea.”

Emma and Edward had two children! Edward Arbuthnot Adcock was born 10-22-1894 in Ribblesdale, he was baptized as Edward Arbuthnot Lacey on 5-13-1899. Amabilis May Arbuthnot Adcock was born May 15, 1896 in Ribblesdale, Dorking, Surrey; she was baptized 8-19-1904 in

Broadstairs, Kent (a month before her father died in the same place). Her birth certificate named her mother as Emma Warner Lacey formerly Sleigh. Her birth was registered twice, as Adcock and Lacey.

Apparently Emma knew Edward before she filed a divorce petition against her husband. It is odd that Edward's divorce, or its claims, was not mentioned in Ernest's petition. Nor that neither child was mentioned during the divorce cases.

(47, born Jan 1854 NJ to parents born NJ) and siblings Stanley (21, born Mar 1879 NJ) and Samuel F. (16, born Nov. 1883 NJ). John's father was a bookkeeper.

In 1910 John Williamson's parents William and Ida lived in Clayton, NJ with no children. [I could not find John or his brothers in the census.]

In 1918 Beatrice and John lived in Rochester, NY at 69 Alameda Street. John was the District Manager for B. F. Sturtevant Company in Rochester at 1108 Granite Bldg.

In 1920 Beatrice Williamson (32) lived in Rochester, NY with husband John (37), daughters Cynthia (7) and Jean (6), and mother Anne Adams (59). Beatrice was born MO. John was an electrical engineer.

On Feb. 5, 1927 Beatrice and John arrived New York on ship *Fort Victoria* from Hamilton, Bermuda. They lived at 546 Michigan Avenue, Evanston, IL.

On 19 Aug 1927 Beatrice A Williamson arrived Quebec on the *Empress of France* from Cherbourg, France; she was born in Chicago, Illinois on Dec. 8, 1885, lived at in Evanston, IL at 927 Michigan Avenue.

In 1930 Beatrice Williamson lived in Evanston, IL at 927 Michigan Avenue with husband John L. (46), daughters Cynthia A. (17) and Jean M. (16), and her mother Anne R. Adams (69, a widow), and one servant. Beatrice was 45, married at age 26, born IL. John was an engineer and Vice President of an engineering company.

In 1938 four Adams arrived New York on the *Nerissa* from Trinidad. They lived in Clearwater, Florida at 301 Hilltop Avenue. They were still living there when they returned from England in Sept. 1949, First class on the *Empress of Canada*. They had arrived on August 12th, sailing on the *Canadian Pacific*.

In 1945 Beatrice and John lived in Clearwater, FL at 301 Hilltop Avenue (per FL census). He was retired with a college education, she had a high school education and was a housewife.

EVSL was piloting a Puss Moth with one passenger, they were taking off from RAF Station Kenley when they collided with a second plane (a Bulldog) that was landing. The two men in the Moth died, the pilot of the second plane walked away with minor cuts about the face. The Moth was scrapped afterwards.

[Note the page above states Lacey's plane was a Puss Moth, but the Civil Aircraft Register above states the Puss Moth was sold to France, while the Gipsy Moth was "impressed" and scrapped soon after the collision. I cannot tell which plane Lacey was flying.]

### Robert Richard Bignell

He is an interesting person. I've pieced together the following information about him. About 1853 he opened the Argyll Rooms on Great Windmill Street, a music and dancing club with a casino. In 1882 he converted them to the Trocadero Music Hall.

The ownership of the Argyll Rooms is not clear. Charles Emile Laurent had a music and dancing license there in 1850, 1853, and 1855. Robert Richard Bignell's . Charles Emile Laurent died May 23, 1857, age 38; his obituary said he was one of the Musical Directors of the Argyll Rooms and a Member of the Royal Society of Musicians.

"It attracted the nobility and the demi-monde (fringes of society) of the period and became famous for its masquerade balls. Because of the rooms notoriety the licence was not renewed and the Argyll Rooms closed in 1878. Between 1878 and 1895 the rooms were leased to a number of theatrical agents until 1895 when Bignell's granddaughter granted a 99-year lease to Lyons [J. Lyons and Company Ltd.]; Bignell having died in 1888."

The book *The English Bach Awakening* by Michael Kassler (2004), available on Google Books, says on page 441 the Argyll Rooms were established in 1850 by Charles Emile Laurent. The club's license was removed in 1857 and restored the following year. The index says Robert Richard Bignell lived from 1811 to 1888.

Henri Laurent was a composer and the music director at the Argyll Rooms. When the dancing license was withheld, Bignell transferred the business to the Adelaide Gallery.

There is a transcription of an ad for Laurent's Casino, Argyll Rooms placed in *The Globe and Traveller*, Wednesday, May 26, 1852 at <http://www.londonancestor.com/globe/adv-casino.htm>

There was a Laurent's Dancing Academy, but I don't know where.

There is a nice history of the area in which the Argyll Rooms were located at <http://www.british-history.ac.uk/report.aspx?compid=41453> "In 1842 the freehold of the building [built in 1744], the ninety-nine-year lease of which was about to expire, was bought by (Sir) John Musgrove of Austin Friars in the City of London. Seven years later the latter leased the exhibition and other rooms for twenty-one years to Robert Bignell, wine merchant, who had been Dubourg's partner or employee. (ref. 11) By 1851 Bignell had opened assembly rooms there called the Argyll Rooms . . . The Argyll Rooms soon achieved notoriety . . . Bignell made a great fortune out of the place, and in 1864 he acquired the freehold of it but he was finally deprived of his licence for music and dancing and the Argyll Rooms closed on 30 November 1878. On 30 October 1882 Bignell re-opened his premises, this time as a music hall called the Trocadero Palace. . . . 'For elegance and comfort' the Trocadero was said to be superior to any other music hall in London, and its programmes were 'characterized by greater refinement, or perhaps we ought to say less vulgarity' than those of its rivals. Despite these

advantages the Trocadero only flourished during the fourteen months beginning in July 1886. . . . In 1888 Bignell died, and his trustees then leased the Trocadero to Samuel Adams. . . . In 1895 Bignell's grand-daughter granted a ninety-nine-year lease of the Trocadero to J. Lyons and Co. Ltd., who converted it to its present use as a restaurant. The principal entrance was moved from Great Windmill Street to Shaftesbury Avenue . . .”

An article originally from the London Saturday Review republished in the New York Times on Nov. 11, 1858 discusses the moral issues, especially prostitution, surrounding the closing of the Argyll Rooms in 1857 and their reopening the next year. ### Butts Estate, Brentford, West London

The Butts Estate is a group of semi-detached houses built on a square in the 1870s in the Georgian style. They are well-regarded for their architecture and, lately, as the home of billionaires. “Butts” originated as an area used for archery butts in the time of Henry VIII. The first home, Brent House, was built about 1694. In 1876 Robert Richard Bignell, a property developer, acquired the property. The home called The Gables was built by Bignell in 1887. It is likely that William R. Lacey and his son Frederick W. Lacey rented The Gables and Brent House from Bignell in 1888 and 1889. In 1921 Emma (Bignell) Sleigh sold off much of the estate, including a dozen houses that are worth \$2 to \$6 million each now.

### Warner Family

The Warner family connects with the Laceys: Emma Warner Sleigh who married Ernest Matthew Lacey was the granddaughter of William Campbell Sleigh and Amelia Warner. William and Amelia were married 1-25-1843 in Waterperry, Oxfordshire where Amelia lived in 1841 with her parents and sister.

Much of what I know about this family is compiled from the census. Amelia Warner's parents were William M. and Rachel Warner. William was born about 1789 in Great Brickhill, Buckinghamshire according to the 1861 census.

This may or may not be the wife of William M. Warner. He was widowed by the 1861 census when he lived in Edmonton, Middlesex (part of London).

In 1851 John Warner, age 23 born Brentmore [Mentmore], Buckinghamshire, lived as head of household in Northallerton, Yorkshire; B. A. Curator of Northallerton.  
In 1861 John Warner, age 33, born Mentmore, Buckinghamshire, lived as head of household in Bradwell, Essex with wife Anna Maria Warner, 27 born East Dulwich, Surrey; he was rector Bradwell Juxton Grove (?).  
In 1871 John Warner, age 43, born Mentmore, Buckinghamshire, lived as head of household in Sedlescombe, Sussex with wife Anna Maria Warner, 36 born East Dulwich, Surrey; he was rector.  
In 1881 John Warner, age 53, born Mentmore, Buckinghamshire, lived as head of household in Sedlescombe, Sussex with wife Anna Maria Warner, 48 born East Dulwich, Surrey; he was clerk in holy orders. He lived with his in-laws Matthew and Mary Anderson, 82 and 78 respectively, born Ireland and Woolwich, Kent respectively. Mathew Anderson was Rector of Kimberton (SP?) and Vicar of Jukon (sp?) Maddsen Sallop (sp).  
In 1891 John Warner, age 63, born Mentmore, Buckinghamshire, lived as head of household in Sedlescombe, Sussex with wife Anna Maria Warner, 57 born East Dulwich, Surrey; John was clerk in holy orders. There was one visitor Matthew Anderson, 92, born Ireland, widower, clerk in holy orders.

It seems likely that John and Anna Maria had no children.

The IGI has an entry for Matilda Warner's baptism on 7-10-1837 at Worminghall, daughter of Thomas and Elizabeth Warner, which is believed to be a submitted entry. The date and location match that of the Matilda Warner in the 1861 census.

There were a number of Warners living in Leckhampstead, Buckinghamshire. There were also Warners living in Waterperry, Oxfordshire.

"Elizabeth Latimer died in 1843, and Edward on 18 November 1845. Under his will he instructed that Headington House [Oxford] and other land and property be sold, and the sale duly took place in June 1848. William Mead Warner, a speculative builder from Banbury, bought the land to the south of London Road, and laid out New Headington village in 1851: it then consisted of the present New High Street and Bateman Street, and the warren of small streets down as far as Wilberforce Street. His son William bought back the field now occupied by Kennett Road, which explains why that area was not developed until much later." Hmm, have found no other record of a son William.

[Banbury is a market town on the River Cherwell in northern Oxfordshire.]

"Richard Warner, aged 62 (fn. 38) , buried April 20, 1775." This gentleman was son of John Warner, Esq. a banker, who is mentioned in the Spectator, as having always worn black leathern garters buckled under his knees, a custom, which his son (who, in no other instance, affected singularity) is said to have religiously observed. He resided in an old house at Woodford-row, called Hearts, built anno 1617, by Sir Humphrey Handforth, Master of the Wardrobe to James I. who is said frequently to have dined there, when hunting in the forest. It afterwards came, by marriage, to the Onslows, and was the residence of Foot Onslow, Esq. father of the Speaker (fn. 39) . This house is now the property of Jervoise Clark Jervoise, Esq. Here Mr. Warner, whose niece Mr. Jervoise married, planted a botanical garden, and was very successful in the culture of rare exotics. The herborizations of the apothecaries were made once a year in this neighbourhood, and the company dined together, after their morning's walk, at the house of Mr. Warner; who published the result of these annual researches, under the title of *Plantæ Woodfordienses*. He claims a place also among dramatic writers, having translated several of the comedies of Plautus. He published a letter to David Garrick, Esq. concerning a glossary to the Plays of Shakespeare, and had made large collections for an edition of his works; but desisted from his intention of preparing it for the press, on the appearance of Mr. Stevens's proposals. In his youth he had been remarkably fond of dancing; and it was not without some reluctance, (when he became more advanced in age,) that he turned the largest room in his house into a library. Mr. Warner bequeathed all his valuable books to Wadham College in Oxford, (where he received his education,) and left an exhibition for a botanical lecturer (fn. 42) ." ### Mysteries

- Did Emma Warner (Sleigh) Lacey marry Stamford Vair Clirehugh? This couple were cited in the 1911 census as married. Stamford joined the Army in August 1914, in 1915 he transferred to the Royal Army Service Corps and eventually served overseas. In a March 1918 letter to the Corps he said his wife was in a nursing home recovering from rheumatic fever. Stamford was discharged from the Corps in 1919. By 1920 he lived in Hove, Sussex. A Mrs. Clirehugh lived there per a 1915 phone book. Emma died there in 1929. Her probate record named her as Emma Lacey, wife of Ernest. I have found no marriage record for Emma and Stamford.
- Matilda Warner age 23, born about 1838 in Waring Hale (or Worming Hall), Buckinghamshire living in 1861 with William M. Warner as his granddaughter. She must be the child of an unknown son of WMW. As of April 2011 I found that WMW had a son John in 1828, making him too young to be the father of Matilda. Perhaps WMW had children from a previous marriage. I continued looking and found what appears to be an earlier marriage for WMW, in 1812. I also found a Thomas Warner born 1818 who had a daughter Matilda in 1837. So far so good. The 1861 census shows Thomas Warner living next door to James Warner, who was three years younger. Both born Leckhampstead, Buckinghamshire. This suggests they were brothers, however the only James (15) in the 1841 census lived in Leckhampstead with 50-year old Sarah (mother?), a lace maker, and siblings(?) Elizabeth (20) and George (15). Nearby was the family of William and Mary Ann Warner and five children. So the mystery continues, I cannot be sure that the Thomas who seems to be the father of Matilda was a son of WMW.
- Anne Rachel Warner (Sleigh) Barton makes her first census appearance in 1891 age 26 as a married woman. Her parents were William Arthur Warner Sleigh and Rachel Fanny Braithwaite Price who married in 1863 and divorced in 1867. Where was Anne prior to 1891? Perhaps she lived with her mother in the 1871 census? I did discover her mother remarried in 1868 and 1871. But have not found Anne in the 1871 or 1881 census.
- Who fathered Ernest Vair Sleigh Lacey who was born seven years after his mother Emma unsuccessfully filed to divorce Ernest Matthew Lacey?
